Stephanie Gooden called the meeting to order at 9:00 am.

Stephanie Gooden asked for a motion to approve the minutes from the September 24, 2025 session. Monte Fenner made a motion to approve. Stephanie Gooden seconded. Motion carried 2-0-0.

Stephanie Gooden asked for a motion to approve a payment schedule. Monte Fenner made a motion to approve a payment schedule as presented. Stephanie Gooden seconded. Motion carried 2-0-0.

County Clerk Brittni Burton presented commission order #6700 in the amount of \$191,198.56 for a cash transfer of payroll, order #6701 in the amount of \$33,795.03 for 941 taxes, and order #6702 in the amount of \$4,545.39 for CERF .7% and elective savings. Monte Fenner made a motion to approve the commission orders as presented. Stephanie Gooden seconded. Motion carried 2-0-0.

County Clerk Brittni Burton presented commission order #6703 in the amount of \$10,896.99 for the September 2025 CERF collections. Monte Fenner made a motion to approve the commission orders as presented. Stephanie Gooden seconded. Motion carried 2-0-0.

County Clerk Brittni Burton presented September additions and abatements. Personal Property additions totaled \$18,811.81. Personal Property abatements totaled \$100.68. Real Estate additions totaled \$8,398.22. Real Estate abatements totaled \$118.54. Monte Fenner made a motion to make the additions and abatements a matter of the minutes. Stephanie Gooden seconded. Motion carried 2-0-0.

Corrections Officer Linda Arnold submitted a request to extend 20 hours of vacation time for 90 days. Monte Fenner made a motion to approve the extension. Stephanie Gooden seconded. Motion carried 2-0-0.

Treasurer Jared Brewer gave a report on the various sales taxes received for the month of October. Sales tax collected in the amount of \$118,193.66. Law enforcement tax #1 collected in the amount of \$88,645.13. Use tax collected in the amount of \$76,132.47. Law enforcement tax #2 collected in the amount of \$29,548.33. Economic development tax collected in the amount of \$118,192.02.

Collector Cindi Sims presented the September 2025 distribution report. Collections totaled \$98,723.41. She stated that there were 1,783 applications approved for the Senior Tax Credit. Her office is working on tax bills for this year. She is going to mail the tax bills of the ones approved for the Senior Tax Credit separately from the rest so she can include a renewal form with their bills. There may be an electronic option for renewal in the future but for right now it will be on paper. All bills will be mailed in November, usually around Veterans' Day. Monte Fenner asked when renewals for the Senior Tax Credit would start. Cindi said she will take renewal forms at any time, but new applicants cannot apply until March.

County Clerk Brittni Burton presented liquor licenses in the amount of \$26 in caterer's licenses for My 3 C's LLC and Leaning Side, and an auctioneer license in the amount of \$55. Monte Fenner made a motion to approve the licenses as presented. Stephanie Gooden seconded. Motion carried 2-0-0.

Monte Fenner reported that he attended a budget meeting at MU Extension on Monday afternoon and next Tuesday he will attend an MSDC meeting at 7:00 am.

Stephanie Gooden reported that she attended a Marshall Chamber of Commerce meeting where they discussed the MVC Block Party happening on October 25th on the Square. She mentioned the annual Trick-or-Treat on the Square will be on October 30th. She stated that the Commission has several meetings happening on October 15th. They will have the quarterly Develop Saline County meeting, and a Salary Commission meeting that day.

Monte Fenner stated that the Jail-Justice project is almost complete. All that is left is to paint the front doors. Also, the roof on the Extension building was completed the previous week. Stephanie Gooden clarified that the Extension building had a flat roof that had some wind damage, and instead of replacing it with another flat roof, they were able to replace it with a pitched roof.

Stephanie Gooden asked for a motion to adjourn at 9:10 am. Monte Fenner made a motion to adjourn. Stephanie Gooden seconded. Motion carried 2-0-0.
